## Hosted Archiving for Exchange, GroupWise & other systems

The Gaggle archiving solution pulls the email data off of your local mail server on a nightly or even hourly basis. The messages are pulled from your mail server and stored on Gaggle's enterprise storage systems in both Los Angeles and Chicago.

Each mail server uses a slightly different archiving mechanism. The most common methods utilize a message journaling feature or a store-before-delete function. Other mail systems require a pass-thru MX or may rely upon mail routing rules. The system supports Boolean search terms with multiple wild cards just like the Google search engine. Sophisticated search options such as proximity searches, fuzzy searches, wild cards and boosted search terms are also available.

Because the search functionality is built into Gaggle's new AJAX interface, it is fast and easy to use. Gaggle's web based interface looks just like an email client such as Outlook. Since there is no complicated system to learn, you'll immediately know how to search for and find the archived messages you need.
